GROUND FLOOR PLAN





TYPICAL FLOOR PLAN






BLOCK A - 1 & 3
BLOCK B - 1 & 3 CORNER UNIT









BLOCK A - 2

BLOCK **C - 1 & 4**BLOCK **D - 1 & 4** corner unit




